STUDIO SHOOT

Nude studio: £150 half day
Non-nude studio: £100 half day

LOCATION SHOOT

Non-nude interior location: £100 half day
Non-nude exterior location: £100 half day
Nude interior location: £150 half day
Nude exterior location: £150 half day



IMPORTANT NOTE!

All models **MUST** be aged 18 YEARS OR OVER.
We require a valid **GOVERNMENT-ISSUED PHOTO ID**, with date of birth clearly shown, as proof of age (driving license, passport, etc.).
For legal reasons we have to retain a copy of your Age ID, though this will be kept secure and private.

TERMS & CONDITIONS SUMMARY

IMPORTANT NOTES FOR MODELS – PLEASE READ CAREFULLY

This is a summary of “Terms and Conditions of Contract” as available at <http://www.girlskissing.co.uk/models/contract.pdf>
It does not replace this contract, or cover every point in it; only summarizes a selection of its clauses – please read the full contract as listed above.

BOOKING CONFIRMATION

All models should provide the following information to confirm a booking:

1. **MODELLING NAME.** As you want it to appear on the website.
2. **REAL NAME.** We need your real name to keep our records legal.
3. **REAL ADDRESS.** We need your real address to keep our records legal.
4. **CONTACT TELEPHONE NUMBER and EMAIL ADDRESS.**
5. **NATIONAL INSURANCE NUMBER** – only if you are requesting to be paid in cash.

Q. WHY DO WE HAVE TO HAVE THIS INFORMATION?

A. We want our accounts to be legal. If we don't have a record of a payment to a model we can incur heavy fines from HMRC, which we will not risk.

PLEASE NOTE: We must have this information at least 24 hours before the shoot is due to take place. If we don't have it within that time the shoot will be cancelled.

AGE VERIFICATION

First-time models **MUST** provide suitable age verification **BEFORE** a shoot takes place. This must be either a passport, driving licence, or other government-approved identification. It must show a photograph, name and date of birth clearly.

MODEL RELEASE

We require **ALL** models to sign a model release form **BEFORE** a shoot takes place. Any and all changes, and/or exceptions requested, to the Model Release must be agreed at least 48 hours before a shoot takes place.

PAYMENTS TO MODELS

We will only pay in cash if you provide your full details, including your NI number, at least 24 hours before the shoot takes place. If you accept payment by cheque or bank transfer no NI number is required.

CHANGES/CANCELLATIONS

Any changes/cancellations must be done at least 48 hours before the agreed date. Cancellations must be communicated by telephone, in person – not by text or email.

TRAVEL EXPENSES

Travel expenses must be agreed up-front - before the shoot - and any expenditure must be backed-up with a valid receipt. If, for some reason, travel has not been agreed prior to the shoot then the maximum we will reimburse is £25. For example: if you tell us your train tickets will be £40 and we agree to that, we can repay the full £40. If you don't tell us how much your travel is going to be, and turn up to the shoot with £40 in train tickets stubs we can only repay £25. This is to protect our business from spiralling travel costs. We refund your travel expenses **IN CASH** on the day.

We prefer working with conscientious models who help us by purchasing their travel tickets appropriately. It's fairly obvious that the easiest ways of booking tickets (online, for example) are the most expensive. Always book train tickets on the phone and ask for the cheapest tickets (usually singles), travelling within our agreed time frame.

We can pay travel expenses up-front, but only if you sign a contract committing yourself to the shoot, in good time, in advance.

We cannot pay travel expenses for partners, companions or chaperones.

HEALTH & SAFETY

Models must inform us, prior to a booking, of any special health and safety requirements in relation to their own well-being and that which may affect other shoot participants. This may include notification of allergies, and if requested, provision of current satisfactory sexual health certification ('certs').

CONFIDENTIALITY

We will keep secure, and not disclose, a model's confidential information, except where we are contractually obliged to, or ordered to by a court, or a government or regulatory authority, or as may be required by law.

SECURITY/PROFESSIONALISM

We are a small team of talented creative professionals working with integrity and honesty. Your well-being and security is of the utmost importance to us and will be our number one priority during a shoot. We want your shoot to be as comfortable and enjoyable as possible, so please call us if you have any suggestions or wish to discuss any aspect of shooting further.
